Entry Changes and Cancellations Refund Policy

Any changes to entries, including cancellations, will be accepted until 48 hours prior to trial start. Changes must be made to the Secretary in email or writing. Cancellations after Jan 10 will not be eligible for a refund. Refunds will only be issued upon written request for dogs or handlers withdrawing for medical reasons or for bitches in heat. Must include a vet or doctor's note. No refund if a competitor is excused for any reason. If the trial must be cancelled, we will do our best to reschedule.

Awards

Ribbons will be awarded for all qualifying runs and Rosettes will be awarded for titles earned at this trial, including Ace titles at all levels. Although there are no placements, each judge will be awarding a special prize at each level.

For the Safety and Comfort of all

- Maintain a buffer between all dogs when passing by.... The more distance the better!
- All dogs must be always on leash unless they are in the ring. No Flexi/retractable type leashes or long lines to be used when walking dogs around the trial site.
- Dogs must be kept quiet and crated in between searches and potty breaks.
- Please keep voices quiet while talking in breezeway as voices are carried and can be quite distracting. ABSOLUTELY NO DISCUSSING THE CURRENT SEARCH UNTIL ALL DOGS HAVE COMPLETED THEIR RUN.
- Venues are hard to come by so PLEASE PICK UP AFTER YOUR DOGS! We would like to trial at the Facilities again. Few places are so dog friendly.

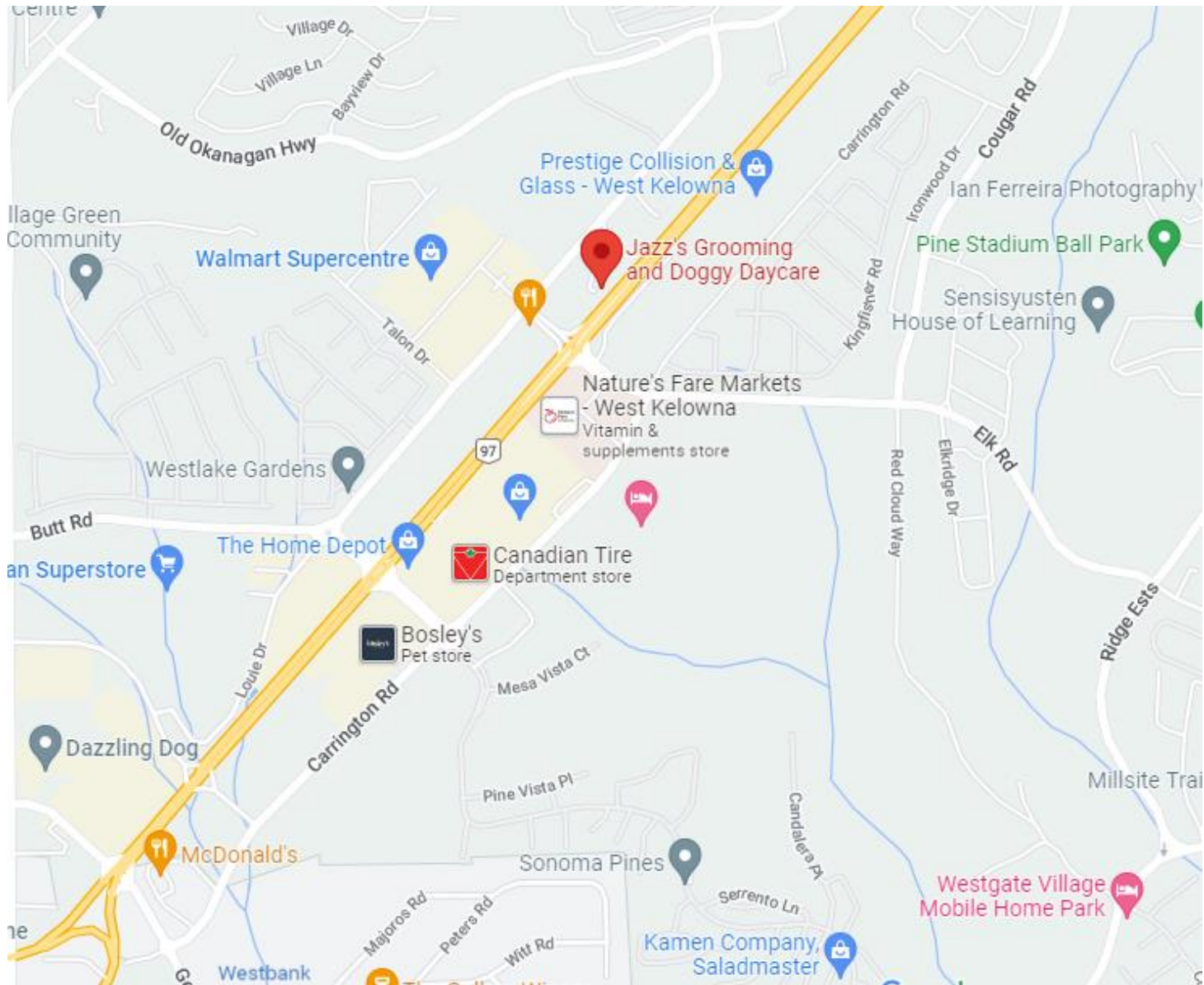
